THE POSITION

The City of Yreka is seeking several experienced individuals with a working knowledge of municipal infrastructure and construction techniques. The ideal candidate would have a Class A commercial driver's license, experience with construction equipment, excavation, plumbing, and electrical. This is a journey-level position and performs the full range of duties required to ensure that City infrastructure, systems, and facilities are maintained in a safe and effective working condition.

SPECIAL REQUIREMENTS:

- 1) Criminal History and Background Check: Applicants will be fingerprinted for the purpose of a search of local, state and national fingerprint files to disclose any criminal record.
- 2) Valid State of California Class A Commercial Driver's License with Air Brake and Tanker Endorsements, or obtain within 180 days of appointment.
- 3) All certifications necessary to perform the work as required.
- 4) Pass a medical examination and mandatory drug and alcohol screenings required for licensing and work assignment.

Successful candidates will be required to pursue and obtain the appropriate Certificate for Water Distribution Operator, currently Grade 1, from the State of California Department of Public Health within 2 testing cycles of date of hire.
