

**FOOD VENDOR REGULATIONS AND APPLICATION – 2015**  
**Scott Valley Bank Summer Concert Series – Miner Street Park**

Yreka Municipal Code Section 9.50.080 prohibits commercial activity in any recreation area. However, a permit may be obtained upon application to the City Clerk if any such activity is for the benefit of a non-profit corporation.

**Description:**

- Vendors will be limited to 5 per event. Should more than 5 applications be received for any event date, participants will be selected in the order in which complete applications are received.
- The exact location of the vending site will be subject to the approval and direction of the Department of Public Works. *Vehicles are not allowed on lawn area.*
- Electrical power is not available. No sound amplifying equipment is allowed. Power Generators shall not be loud enough to conflict with concert music.
- Concerts at Miner Street Park are from 6:30 p.m. to 8:30 p.m. Booth set-up must be completed by 6:00 p.m. and sales should end by 8:30 p.m. to ensure that the park is cleared and cleaned up promptly after the concert.

**Requirements:**

- Vendor must supply a copy of Health Department Certification for all sales of non-packaged products (not required for sales of purchased, packaged items in sealed wrapper such as soda in cans, bottled water, popsicles in wrapper, etc.)
- Vendors must provide proof of \$1,000,000 liability insurance **naming the City of Yreka as additionally insured.**
- A **\$50.00** Clean-up/damage deposit is required for each event. This deposit is fully refundable only in the event the entire vendor area is left as it was found. For vendors who request more than one concert, this deposit can carry-over from one event to the next provided you qualify for the refund. Area must be cleaned immediately following the concert. Trash receptacles will be provided for the general area. Please provide your own trash receptacles for inside your booth.
- All vendors, including non-profit organizations, are required to obtain a City of Yreka Daily Business license for this specific event. The business license fee is \$5.00 per event. Non-profit organization/service groups may be eligible for a “fee waiver”.
- All Vendors must submit proof of non-profit status or a copy of letter from a non-profit organization acknowledging your pledge to donate a percentage (1-100%) of the proceeds to the non-profit organization.
- No alcohol sales are permitted.
