Appeals must be submitted to the City Clerk's office together with the appeal fee. If you challenge any action taken pursuant to the California Environmental Quality Act, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Planning Department at, or prior to, the public hearing. (Public Resources Code Section 21177). If, in the future, you wish to challenge in court any of the matters on an agenda for which a public hearing is to be conducted, you may be limited to raising only those issues which you (or someone else) raised orally at the public hearing or in written correspondence received by the City at or before the hearing. Any person seeking to challenge a City Council decision made as a result of a proceeding in which by law a hearing is required to be given, evidence is required to be taken, and the discretion in the determination of facts is vested in the City Council, shall be required to commence that action 90 days following the date on which the decision becomes final as provided in Code of Civil Procedure Section 1094.6. Please refer to Code of Civil Procedure 1094.6 to determine how to calculate when a decision becomes "final."

a. 2022-33 Carnegie Library Historic Building Exterior Alteration: Public Hearing

The Planning Commission will consider the following historic building exterior alteration application filed by ORW Architecture on behalf of the Siskiyou Economic Development Council. The proposed project consists of the installation of a balcony to the existing Carnegie Library, 412 West Miner Street. The balcony addition is planned in conjunction with the historic rehabilitation of the building, intended for reuse by Siskiyou County Economic Development Council.

8. OLD BUSINESS:

a. MC-2022-03 Undergrounding Regulations

The Planning Commission will review and consider the first draft of changes to the municipal code related to undergrounding aerial utilities.

Recommended Action: Provide Staff Direction

Commissioner Ohlund spoke to who should carry cost (of undergrounding) and discussed how residents have already borne the burden of utility installation, and that asking the rate payer to carry that cost burden again seemed counter intuitive.

Commissioner Devlin spoke to opportunities through grants and construction for undergrounding utilities.
Commissioner Devlin spoke to continuing the discussion on undergrounding utilities.

Commissioner Fernandez voiced a concern of undergrounding stifling redevelopment.
Planning Director Juliana Lucchesi made note of the commissioners concerns for undergrounding and will bring back the item incorporating their comments.
