Utility Rate Increase

October 1, 2010, marks the third year of a 5-year rate increase on water and wastewater utilities. The 5-year plan was adopted by the City to cover the cost of operations and make much-needed repairs to the water and wastewater systems. A detailed report of the utility rate study is available at City Hall. As a result of the new rate structure, the City has received \$10 million in grant and loan funds from the US Department of Agriculture, Rural Development, for the water treatment and distribution system. Public Works Receives Project of the Year Award

The Sacramento Chapter of the American Public Works Association (APWA) recently notified the City of Yreka Department of Public Works that it won a 2010 Project of the Year award for its \$5 million Stormwater Attenuation and Floodplain Restoration Project. The project will reduce future flood damages in the community by completing many of the large projects recommended in the City's Master Plan of Drainage and will improve water quality in the sensitive Klamath River watershed.

Public Works staff attended an awards luncheon in Sacramento on August 19th to accept the award and presented the award plaque to the City Council at its meeting that night. This is the largest single grant received by the City and its largest grant project to date. This Project of the Year award is in the Environment Category, Construction Division, \$2-\$10 million, Agency Size: Small. This award recognizes excellence in management, administration, design, construction, and community relations. It also celebrates the partnership between City staff, the funding agencies, engineers, consultants, and contractors who worked together to complete the Public Works project.



The Public Works Department and the Yreka Creek Committee, a volunteer advisory group, partnered on this project to mobilize an impressively wide array of support. These volunteers were critical to the project's success and also obtained additional project funding from the California Urban Streams program, the California River Parkways program, and the US Fish and Wildlife Service Partners for Fish and Wildlife program. Summer of 2010 Chip Sealing

Many streets in Yreka were rehabilitated last summer with a chip seal because the City received \$400,000 from Proposition 1B approved by California voters in 2006. A chip seal is placed to extend the life of paved streets. It seals the existing pavement against water intrusion and provides a new wearing surface that can extend the life of the pavement for 5 to 8 years or more, depending on the volume of traffic and the condition of the street.

Fall Creek Water System Improvements

The City recently opened bids for the Fall Creek Water System Improvements that will make critical improvements in the water supply, treatment, and distribution facilities in order to meet new regulations. On September 2nd, the City Council authorized a contract with the lowest bidder, T & S Construction from Sacramento, who will be using some local subcontractors for parts of the work. Work will begin soon and will take approximately 2 years to complete.

A \$6.8 million loan and a \$3.2 million grant that includes funds from the American Reinvestment and Recovery Act (ARRA) has been received from the US Department of Agriculture, Rural Development. This funding would not have been approved without the recent increases in utility rates. Among other things, the project will replace deteriorated supply mains, install a new storage tank, add a recycling system, and upgrade the treatment and supply systems to more reliably provide high-quality water to serve residents.
