City of Yreka Annual & Prorated Business License Fees

A state fee of \$4 has been added to Business Licenses, effective January 1st, 2018, as part of SB 1186. This \$4 fee is for the Certified Access Specialist program (CASP), which is designed to improve Americans with Disabilities Act compliance.

Business License Fee Types & Fees

Fee Type	Fee
Business License Fee - Business located outside City Limits	\$45 annually plus \$4.00 SB 1186 = \$49.00 total Calendar year January - December
Business License Fee - Business located within City Limits	\$30 annually fee plus \$4 SB 1186 = \$34.00 Calendar year January - December
Motels and RV Parks License Fee	\$34 up to 5 rooms, additional rooms/spaces are \$1.80 each (includes SB 1186 fee).
Home Occupation Permit	\$75 one-time fee, plus annual business license fee
Peddlers/Vendors/Solicitors	\$5 per day
Retail Merchants License Tax	\$34 first year - 2nd-year fee based on gross receipts (includes SB 1186 fee).

Prorated fees for businesses located within city limits & businesses outside city limits & doing business within city limits.
